# Terms and conditions

#### Booking and payment

All prices are quoted in Australian dollars and exclude GST (10% Goods and Services Tax).

Sponsorship packages will be allocated only on receipt of the signed application form.

Confirmation will be sent together with a tax invoice for the full amount. The invoice is payable within 10 days of the date of tax invoice. If the payment is not received within this timeframe, then you relinquish your right to the requested sponsorship package.

All payments should be made in Australian dollars by bank transfer or credit card (Mastercard, Visa or American Express). Payments made by credit card will attract a 2.8% fee to cover commissions.

Entitlements will not be implemented for the event/s until full payment has been received.

Sponsors consent to their contact details being shared with event suppliers and contractors.

### Cancellation policy

If notification of cancellation of sponsorship is received in writing:

- 30 days prior to the nominated event date, you will be refunded 50% of the fee.
- 14 days prior to the nominated event date, you will be liable for 100% of the package selected.

The Organising Committee reserves the right to cancel the event in case of circumstances beyond its control. In such a case all monies paid to date will be refunded in full less any expenses incurred prior to cancellation. The liability of the organisers will be limited to that amount.

# In-person events / COVID-19 restrictions

In the event of restrictions on large gatherings or other impacts due to COVID-19 or other conditions, the PMAA presentation will move from an in-person event to a virtual option, or the event will be postponed.

If moved to a virtual event, AIPM will advise the sponsor and will transfer the in-person sponsorship to a virtual sponsorship. In the case of the sponsor not wishing to pursue sponsorship of the event virtually, a fee of 25% of the package cost will be charged for administration fees as well as promotions already placed.
